

# First cycle professional programme: B.Sc. (Hons) COSMETICS

Study program has been approved by the Council for Higher Education of the Republic of Slovenia on 20.11.2007.

1st cycle professional study programme

Official length of study programme: 3 years (6 semesters), 180 ECTS credits

Access requirements: The access requirement for study is the matura examination or the vocational matura examination or the final examination under the four-year secondary school or equivalent programme.

When enrolment is limited, the following selection criteria are applied: average grade of matura or vocational matura or final examination (up to 60%) and average grade in the  $3^{rd}$  and  $4^{th}$  year of secondary school (up to 40 %).

### Information on the contents

### 4.1 Mode of study: full-time or part-time

Attendance on exercises is obligatory. Study requirements are determined by the respective course programmes. In 3<sup>rd</sup> year students are obliged to do 70 hours of practical work in the fields of study program. Upon the successful completion of exam requirements, students prepare an undergraduate thesis and defend it in a public presentation.
